CONTRACT FOR DEPOSIT

With the protection and preservation of my dogs' indigenous European bloodlines, all DACHSHUND CENTRAL puppies are structurally and temperamentally suited for a companion or obedience dog: This puppy will be current on all immunization shots, as well as its first deworming—replete with puppy packet folder and sample food—plus the option of an AKC Reunite Microchip at no added cost.

For any puppies to be held longer than their reasonable 9 weeks of age, a charge of \$15 per day (or \$100 per week) must be added for board; any additional vaccinations due will be charged \$20 for each—should arrangements not otherwise be made by SELLER and BUYER at signing of this contract: In the unlikely occurrence your puppy is developing undersized or not eating well at 8 weeks of age, and a longer stay with SELLER is advised, then no additional charges will be applied; should the unforeseen occur, the BUYER will have his or her first choice of another puppy, when one becomes available.

A nonrefundable, \$200 minimum deposit against the total purchase balance shall be due upon signing—failure to pick up your puppy must regrettably result in forfeiture of deposit, and puppy will be placed back up for sale again:
